Top of the Signpost

As a small child I remember sitting with JoJo's daycare kids in one of EMES's first-grade classrooms. I wasn't exactly sure why I was there—I was five years old—or what Town Meeting was, but I remember the excitement, how the adults around me packed the blue-tiled hallway and filled the air with their conversations. I also remember the jumbo box of Goldfish for us kids to dig into. Thirteen years later, I'd call the feeling a sense of community engagement and passionate participation. This is what makes Town Meeting such an important part of local Vermont community government. Town Meeting offers our community the chance to debate, compromise, and collaborate, to envision our town's future, together.

The tradition of Town Meeting is fueled by civic and civil participation. For nearly two centuries, people, driven by passion, be it for an efficient school budget or safe roads, have come to voice their opinions and engage in one of the few direct democracy systems left in our country. The utility of Town Meeting lies entirely in the strength of community turnout and the commitment to treating the discussions that are the bedrock of a functional democracy with respect, dignity, even reverence. With such turbulent and corrupt national politics as we are experiencing, each and every local voice has never had higher value than right now.

Similarly, the voices of kids, students—the next generation—have never been more important. Children really are the future, and the discussions at Town Meeting, and at every level of government, must represent their interests. As I did when I was five, today's children are listening, watching, learning from the example set at EMES on Town Meeting Day. Encouraging civil engagement from the next generation not only strengthens our lives today, as a new spectrum of ideas are presented, but also secures a local government process that will keep our communities engaged for generations to come.

So this March 7, bring your daughter, bring your son to EMES. Let them wander around, listening to conversations and debate, joining in if they want. Encourage them to research the ballot and participate in the forum on Saturday, March 4. Because the more passionate and varied perspectives we can bring into our town discussions and decisions today, the stronger our town, communities, and country will be tomorrow.

Coming Up at Town Meeting

In addition to discussing the regular budgetary items that enable the operations of the Town and School District, there are several special items on the Town Meeting Warning of special interest. The details of each item are found in the Town Report that has been mailed to each household.

Article 5: Amendments to the East Montpelier Charter

The amendments provide for the selectboard to appoint the town clerk, collector of current taxes, and collector of delinquent taxes; the elimination of the obsolete offices of fence viewer, weigher of coal, and inspector of lumber, shingles, and wood; and an updated selection committee to ensure direct citizen involvement in the appointment of both the town clerk and town treasurer positions. The selectboard and the charter committee, which recommended these amendments, share the belief that these changes will, in the words of the committee's report, "help assure a well-functioning office with officers working to accomplish common goals in an accountable fashion."

Article 6: Dissolution of EM Fire District #1

EM Fire District #1 was created in the summer of 2010 for the sole purpose of acquiring the Crystal Springs Water System and providing potable water service to the East Montpelier Village area. After six years of fruitless negotiation with the owner of Crystal Springs, the Prudential Committee of the fire district asked that the town take the necessary steps to enable the fire district to dissolve.

The formal process to merge the district with the town requires three steps. The first occurred on January 11, 2017, when the registered voters of the fire district voted to accept the Plan of Merger at the district's annual meeting. The second will be the town Australian Ballot vote on the Plan of Merger on 2017 Town Meeting Day (Article 6). The final hurdle will be approval by the Vermont legislature of the Plan of Merger as an amendment to the East Montpelier governance charter. If the final two steps are completed successfully, the fire district will cease to exist on July 1, 2017.

Article 13: Monetary support for Cross VT Trail bridge project

The Cross Vermont Trail (CVT) project includes a 4.5-mile stretch through the southeastern part of town, generally along the old rail bed, and linking to other trail networks. The key element for this part of the trail is the construction of a bridge across the Winooski River. The \$1.6M cost of the bridge will be funded largely by federal grants. To meet a local match of \$250,000, a one-time town appropriation of \$7,500, coupled with similar support from Montpelier, Calais, Berlin, and other Central Vermont communities, is sought.

Article 18: Sanctuary Community policy

The Selectboard placed this non-binding resolution on the ballot after being contacted by many residents interested in taking such a stance as a town. The discussion and vote on the floor at Town Meeting will show where sentiment in town lies.

They Want Your Vote

Descriptions taken largely from the VLCT Resource Manual and Vermont Law

Town and School District Moderator

(elected separately; may be one or two individuals): one 1-year term

The moderator is the presiding officer of municipal and school meetings and shall decide questions of votes taken, except if Australian ballot is used. The moderator shall preserve order in the conduct of business and meetings.



Michael Duane: I am running for re-election for the positions of Town and School District Moderator. My wife, Ellen, and I have lived in Vermont since the mid-1970s, and have been residents of East Montpelier for over 30 years. I served as president of the Washington Electric Co-op from 1991 to 1998, during which time I

presided over the monthly and annual meetings. I have also served on the Town Ancient Roads Committee, a town committee to explore the effect of land conservation on the property tax rate, and more recently on the town Charter Committee. I am also a member of the East Montpelier Historical Society, and was a member of the board of the Hunger Mountain Coop from 2008 to 2011. As Coop president during my final year, I presided over the monthly and annual meetings. I have served as East Montpelier Town and School District Moderator for the past two years and would be honored to serve again.

Selectboard Member

one 3-year term; one 2-year term

Selectboard members are responsible for general supervision of the affairs of the Town and are responsible for seeing that all duties, not assigned by law to any particular officer, are carried out. The Selectboard convenes Town Meetings and may enact ordinances and rules that regulate areas such as roads, traffic, waste disposal, animals, and nuisances as examples.



Amy Willis, 3-year term: I would be honored to serve my East Montpelier neighbors on the Selectboard. My professional background is in finance and economics, which I believe will serve the community well as we continue the challenge of budgeting and keeping tax rates in check. One of my primary interests

in serving on the Selectboard stems from the work done by the Planning Commission and other groups that have envisioned the future of the village center and town as a whole. I want to further the goals outlined in the extensive town plan, promoting commercial interests when they make sense while keeping a firm hold on the soul of our community. My recent local board appointments include Montpelier Alive, Lost Nation Theater, Eleva Chamber Players, and the Unitarian Church of Montpelier (I was president of the church from 2014–2016, and vice president in 2013). I currently serve on the local advisory board of ReSource, and was on the 2016 Vermont Book Award Committee.



Kim Swasey, 2-year term: Thank you for the opportunity to serve another term representing you on the East Montpelier Selectboard. For those of you who don't know me, I was born in Montpelier and graduated from Montpelier High in 1982. After graduating in 1986 from the University of Vermont, I was commissioned

into the United States Army and served in various assignments around the world, including the Republic of Korea. I retired from the Vermont Army National Guard in 2012 as a Lieutenant Colonel.

After retirement, I had the good fortune of being appointed to the East Montpelier Selectboard and have continued to serve since that time. In this capacity as a public servant, I earned a Master's of Public Administration from Norwich University in 2014 and continue to pursue my interest in leadership by enrolling in the Snelling Center for Government, Vermont Leadership Institute.

Taking seriously the notion of representative government, I approach this opportunity with an open mind, ready to listen, and then act based on what will be best for East Montpelier. In local government I believe discussions with community members enable us to work toward a common goal. I believe that we must look closely at our future in Vermont and through long-term planning, nurture an economically friendly community for people to grow up, prosper, and raise their own families. Town Clerk

one 3-year term

The town clerk carries out many of the operational roles of the town office including recording, preserving and certifying public documents, administering oaths of office, complying with public information requests, posting notices on the town's bulletin board, running the local elections, maintaining the grand list, selling fish and game licenses, issuing marriage licenses, and licensing animals. The town clerk may assume unofficial duties as agreed to with the Selectboard.



CJ Flynn, one year of 3-year term: It has been a fantastic experience being the town clerk in East Montpelier. When the opportunity became available to serve our community as town clerk, I readily applied. Despite there being significant interest in the community in general, I was fortunate and proud to be appointed to the position

of town clerk by the Selectboard, through Town Meeting 2017. I will now run for election to the one year balance of the elected term.

My wife, Kristi, and I have lived in East Montpelier for almost 14 years, Kristi having grown up here. We have been coming here for longer than the almost 25 years we have been married. We have three children educated in the EMES and U-32 system and have been very involved in both schools and in the community. I have been fortunate to be able to contribute to the community as a whole, through leadership in the local East Montpelier Cub Scout Pack/ Boy Scout Troop 742, as well as by volunteering on the Community Connections Advisory Board, coaching local sports, tutoring, and serving on the East Montpelier Recreation Board. Lister

one 3-year term

Listers are responsible for determining the value of the real and personal property in town. This is the value the Selectboard or the Town will use to set a tax rate necessary to raise the money

to operate the town in the next year. It is also the basis for the determination of the property wealth of the municipality for purposes of setting state education property taxes.



Rob Chickering, 3-year term: I would appreciate your vote this Town Meeting Day for me to continue to serve the town as a lister. I have served in this capacity for the past six years and believe that I am well qualified to continue in this role. I have served the town in the past as a Planning Commission member and as a selectman.

The role of Lister is quite different, in that it involves few public meetings. It is a technical job that determines the assessed value of properties in our town, using computer programs that have been developed for this purpose for Vermont. Having experience with this technology enables me to work efficiently in this role.

Town Auditor

one 3-year term

Town auditors are responsible for examining and adjusting the accounts of all town and school district officers and all other persons authorized by law to draw orders on the town treasurer. Secondly, they are to report their findings in writing to the legal voters of the town, presenting an easy-to-understand picture of the town's finances.

First Constable:

one 1-year term

East Montpelier has voted to prohibit constables from exercising any law enforcement authority. The constables serve as animal control officers and may be called on to serve civil or criminal process and to aid first responders when necessary.



Sandy F. Conti: I have served as the Town's First Constable and Animal Control Officer for ten years and still find it interesting and, at times, challenging. I enjoy the opportunity to give back to the town that I have called home for more than 20 years. I would appreciate the opportunity to serve as the first constable for an eleventh term.

one 1-year term

Planning Commissioner:

three 3-year terms

The Planning Commission is responsible for preparing and maintaining a current Town Plan and Zoning regulations. It reviews significant developments and makes recommendations on issues including land development, transportation, economic and social development, historic, wetland, and scenic preservation.



Scott Paul Hess, 3-year term: I am running for re-election to the Planning Commission. My six years of service on the Commission has been very rewarding. During my last term, the Commission has worked extensively on water erosion issues, and we are currently drawing up a development plan for East Montpelier Village. I was

East Montpelier Students: Best in State

The Amazon River Dolphins, a group of students from East Montpelier, has been named "Best in State" in the fifth annual Verizon Innovative Learning App Challenge for their smart phone app, Reuse-It. Team members are (left to right in photo) Jack Thompson, grade 6; Henry Kasulka, grade 6; Logan Wood, grade 6; Ruby Singer, grade 8; and Jacob McCoy, grade 8. The team, sponsored by the EMES Parent Teacher Neighbor Organization (PTNO), created an app to help people more effectively deal with items they're discarding by answering questions about what can be recycled as well as locations for disposal.

The Verizon Innovative Learning App Challenge is a nationwide competition for students to design a smart phone app aimed at "solving societal issues in their schools and communities." The learning experience is meant to spark greater interest in STEM subjects—science, technology, engineering, and math.

More than 1,800 middle- and high-school teams from across the country competed, with only 94 entries being awarded the title "Best in State." The East Montpelier team earned a \$5000 award from the Verizon Foundation for the EMES PTNO and tablets for each of the students.

The team is now in the running for one of eight "Best in Nation" awards, selected by education and industry experts. Winners receive an additional \$15,000 and the opportunity to work with MIT Media Lab experts to bring the app to life.

U-32 Report

We face a very challenging budget outlook this year with an expected decrease in our student population, a sharp increase in student special needs, and additional state-mandated expenses for required software. At the same time, we are evolving to a personalized instruction and proficiency-based learning system that our teachers, administration, and board believe is best for our students. The details of our analysis, discussions, and decisions are in the Town Report

Please note that this year there is a potentially misleading accounting change due to state requirements regarding special education and transportation expenses that make it impossible to directly compare the proposed budget with prior years. This is a one-time accounting change which is explained in more detail in the Town Report. At the meeting next year we will again be able to compare "apples to apples." The board greatly appreciates the support of our community in the education of our young people.
