Pandemic Town Meeting: One More Time

A year ago, when the Town of East Montpelier changed the format of the 2021 Town Meeting Day to accommodate the reality of the pandemic, we all looked forward to meeting as a community in 2022. However, the battle against the Covid-19 and its various mutations continues. The Selectboard has decided, once again, that a traditional in-person meeting cannot be held safely. Instead, we will have opportunities to discuss our town's business virtually; and to ensure citizens can vote easily and without risk, school and town ballots will be mailed to all active voters. All issues that would traditionally be voted on the floor at Town Meeting will be included on the paper ballot.

Your ballots will look a bit different this year due to a nationwide paper shortage. They will arrive in a business size envelope that carries the "Election Mail" indicia and the town's return address. Inside you will find two ballots (white for the town and gray for the school), a very small certificate envelope and a return envelope addressed to the town clerk.

- Complete the certificate envelope
- Complete both school and town ballots; fold and place in certificate envelope
- Put that sealed certificate envelope into the return envelope
- You may mail the completed ballot packet, bring it to the town office, or drop it in the secure drop box outside the town office building (see photo)

If you receive a ballot that doesn't belong to you, please write "RETURN TO SENDER" on it and put it back in your mailbox. Alternatively, bring it to the town office.

The ballot for the Central Vermont Career Center is not available to be mailed with your other ballots and MUST be requested separately from the town clerk's office for early or absentee voting. Alternatively, you may choose to come to



the polls on Town Meeting Day to vote this ballot in person.

In-person voting will be available on Tuesday, March 1, 2022, at the East Montpelier Elementary School from 7 am—7 pm. Covid-19 safety precautions will be in place, and curbside voting will be available for those who wish to vote in person but do not want to enter the building. School restrooms will not be available for public use. If you come to the polls on March 1, please bring your ballot with you. You may simply hand it in or vote your ballot on site. If you forget to bring your mailed ballot with you, we will ask you to sign a form stating that you have not yet voted before giving you another ballot.

TOP OF THE SIGNPOST

In East Montpelier, once again we'll have a Zoom forum, ballots mailed to everyone, and in-person voting on Tuesday, March 1st, Town Meeting Day.

So let us invoke some gratitude to counter that gloomy prospect. Recently returning from a trip to metropolitan Washington, D.C., I am newly appreciative of clean air, respectful (and limited) traffic, dark silence at night, chickadee chirps, and moonlight on snow. We are so lucky to have them. And we are grateful.

Then there are our neighbors—a whole panoply of people whom we know, care about, and depend upon. We enjoy connections ranging from simple texts and calls, to greetings on the street, to the joy of small gatherings. Our strong community has held together over these two years. We can count on that, whatever may come. And that knowledge/ those practices counter whatever the pandemic may throw our way.

Central VT Career Center School District: You Decide

The Central Vermont Career Center (CVCC) is a regional career and technical education school that provides students from Cabot, Harwood, Montpelier, Spaulding, Twinfield, and U-32 high schools (representing 18 towns in all) with opportunities to experience real world technical work in preparation for postsecondary education and careers. It has, most recently, been operated by the Barre Unified Union School District board with a regional advisory board (RAB). Under this structure, Barre voters have had sole responsibility for the CVCC budget.

Since April 2021, CVCC has had a governance committee exploring the creation of a new CVCC district (CVCCD) which would be governed by a board representative of all its sending schools. The committee has developed articles of agreement and bylaws for a potential new CVCCD. Some key points of those documents include:

- A 10-member board
- Four at-large members representing the four largest districts
- Six members appointed by the sending school districts
- The current bargaining agreement, once reached, would be retained for its duration
- Votes for the new governance model and for the atlarge board members will be co-mingled across the 18 towns before counting

This proposal is designed to capitalize on state data that show that students who attend career and technical education programs are more likely to stay in Vermont. This new representative district will allow us to make the decisions necessary to support students across Central Vermont to access our programming. The proposed formation plan report has been approved by the Agency of Education and the State Board of Education.

On Town Meeting Day, March 1, 2022, the 18 sending towns will vote on the new governance structure and elect the at-large board members who will serve should this plan be approved by voters. Upon approval, a transition board—both elected and appointed board members—would begin preparing for the opening of the new district on July 1, 2022.

Ballots to vote on the possible formation of the Central Vermont Career Center School District are available by request or at the polls on Town Meeting Day. Job descriptions taken largely from the VLCT Resource Manual and Vermont Law

TOWN MODERATOR: one 1-year term

The moderator is the presiding officer of municipal meetings and shall decide questions of votes taken, except if Australian ballot is used. The moderator shall preserve order in the conduct of business and meetings.



Michael Duane: I am running for re-election for the position of town moderator, which I have held since 2015. My wife, Ellen Knoedler, and I have lived in East Montpelier for the past 40 years. We raised our three children in East Montpelier, and we now have two grandchildren who also reside in our town and attend East Montpelier

Elementary School. I am a retired attorney after 35 years of practicing law and now spend my days gardening, babysitting, skiing, hiking, traveling, and cutting wood. As moderator, it has been my practice to attend the Selectboard meetings when the annual Town Warning is being prepared so that I have an understanding of what issues may arise at the upcoming Town Meeting. I believe I have a pretty good grasp of Robert's Rules of Order and Vermont state laws as they pertain to Vermont town meeting procedures. It would be my honor to serve as East Montpelier's town moderator for another term.

SELECTBOARD MEMBER: one 3-year term; one 2-year term

Selectboard members are responsible for general supervision of the affairs of the town and are responsible for seeing that all duties, not assigned by law to any particular officer, are carried out. The selectboard convenes town meetings and may enact ordinances and rules that regulate areas such as roads, traffic, waste disposal, animals, and nuisances as examples.



Carlton "Carl" Etnier, 3-year term: no statement



Jon Jewett, 2-year term: I'm running for a second 2-year term on the East Montpelier Selectboard, and I would appreciate your vote on Town Meeting Day. My wife, Sylvia, and I have lived in East Montpelier for more than 40 years. East Montpelier has been a great place to live and raise our family. I retired from being Town

Manager in Hardwick in 2018 and wanted to give back to the community where we have lived for so long with service on the Selectboard.

The last two years have been a significant learning event for all of us in managing our day-to-day lives. During this pandemic, we have given up a lot to keep ourselves, our families, and others safe. For those of us in government, the challenge has been to keep our offices open, providing the necessary services we all depend on. This work has not been easy and has required many difficult decisions by the Selectboard. In addition to the on-going pandemic, the next two years will likely see a significant transition in staffing in East Montpelier's Town Office as key employees retire and others move on to new opportunities. I would like to help the town work through these staffing changes to hire new employees that can carry on the town's important duties as we (hopefully) come out of the pandemic and return to more normal lives.

I want to add that I am personally proud of the town's continued support of our aging residents through our appropriations to the Montpelier Senior Activities Center, the Twin Valley Senior Center, and Vermont Home Health and Hospice program. Programs provided by the Twin Valley Senior Center help to keep older Vermonters healthier and independent longer, so they can stay at home. Thank you for your support.

LISTER: one 3-year term; one year of a 3-year term Listers are responsible for determining the value of the real and personal property in town. This is the value the selectboard or the town will use to set a tax rate necessary to raise the money to operate the town in the next year. It is also the basis for the determination of the property wealth of the municipality for purposes of setting state education property taxes.



Deborah Fillion, one year of a 3-year term: In my role as town auditor, I have worked with the listers to review their annual changes to the grand list and have come to understand the importance of their responsibility. Back in 2009, I spent several months working with the town listers and Vermont Appraisal Company

to assist in East Montpelier's town-wide reappraisal. I went on some residential site visits and did a lot of data entry and analysis. The project involved all of us learning the new computer assisted mass appraisal program called CAMA. It was quite a change from recording the specifications of a structure in pencil on a traditional lister's card. But the job is still the same. Town listers determine everyone's fair basis for taxation and maintain the grand list in an equitable and transparent way. It's a job that requires judgment based on experience. Listers Ross Hazel and Chris Racanelli together have 25 years of experience. I look forward to working with them on your behalf.



Chris Racanelli, 3-year term: This is my third term as lister. In the six years I have been a lister, it has been good meeting neighbors in the community while learning how to evaluate properties and land here in East Montpelier. I look forward to another term and appreciate your vote. Thank you.

FIRST CONSTABLE: one 1-year term

East Montpelier has voted to prohibit constables from exercising any law enforcement authority. The constables serve as animal control officers and may be called on to serve a civil or criminal process and to aid first responders when necessary.



Johnathan Boucher: no statement

TOWN AUDITOR: one 3-year term

Town auditors are responsible for examining and adjusting the accounts of all town officers and all other persons authorized by law to draw orders on the town treasurer. Secondly, they are to report their findings in writing to the legal voters of the town presenting an easy-to-understand picture of the town's finances.



Deborah Fillion: In my 21 years as an auditor for the Town of East Montpelier, I've found a lot of satisfaction not only in getting a bunch of numbers to add up perfectly and suddenly make sense, but also in presenting them in a clear, user-friendly way so that townspeople can make informed choices when voting. One of the biggest rewards of

this office is putting together the annual town report, which centers on connecting our community members with one another. And it's fun to discover just the right photo for the cover (I've featured my dog on the cover only twice, so far). I'm grateful for the opportunity to collaborate with those who provide reports of their activities, as well as my fellow auditors past and present, and the townspeople who support our work. The auditors have been more active at times when our support was needed in observing the town's financial processes. This coming year, with a new town treasurer to be hired, I look forward to helping in whatever ways may prove useful to our new colleague.

PLANNING COMMISSIONER: three 3-year terms; one year of a 3-year term

The Planning Commission is responsible for preparing and maintaining a current town plan and zoning regulations. It reviews significant developments and makes recommendations on issues including land development, transportation, economic and social development, historic, wetland and scenic preservation.

Spencer Hardy, one year of a 3-year term: In November, I



was appointed to fill a vacancy on the Planning Commission and am now running to serve the remainder of the term. While I've only lived in town for a year, I've grown up in Vermont and gotten to know many different parts of the state. I have found the East Montpelier community very welcoming, and I appreciate the abundant

open space, vibrant village, and working landscape of my new home. I currently coordinate an inventory of the state's wild bees for the Vermont Center for Ecostudies (a Hartford based non-profit). Through this work I spend a lot of time thinking about how to maintain healthy pollinator populations in a rapidly changing landscape and how to meaningfully engage the broader community with the natural world. I also own a cooperative vegetable farm with my partner, Jacqueline Huettenmoser, and two friends. This has provided first-hand experience on how challenging land access can be for young farmers and how many pressures our open lands face. I joined the Planning Commission to advocate for the maintenance of our natural and agricultural landscape alongside intentional, equitable growth of our population centers. If honored with your vote, I intend to listen thoughtfully and provide input where my experiences and background can support the goals of the community.

Zachary Sullivan, 3-year term: I've lived in East



Montpelier since 2014 and have served on the Planning Commission for three years, serving as chair for the past year. I enjoy being able to use my background in public policy to help plan for the town's future. I am particularly interested in balancing the needs to encourage development, maintain the rural character of the town, and

protect contiguous forest and agricultural land. I believe that there are creative ways of doing this that will allow us to make gains in all of these areas. I am also interested in making East Montpelier a more affordable place to move to, especially for young families, and in creating land use plans that will make that more feasible. Finally, I am dedicated to continuing to improve the town's planning documents to give East Montpelier a strong foundation from which to engage with state regulators in areas such as commercial energy development, to ensure that the town's interests are given weight by the state, and to help residents understand how they can engage in these processes.



Kim Watson, 3-year term: Thank you for letting me support the community as a planning commissioner and as a member of the Development Review Board for the last 15 years. I wish to continue in that role for another three years, and I would appreciate your vote. I have a strong interest in guiding development of residences, home businesses, and other allowed uses in ways that minimize their impact on the working and natural environment. I have lived in East Montpelier for over 36 years and have worked for the last 41 years in environmental consulting. I will continue to serve as best as I can.

WASHINGTON CENTRAL UNIFIED UNION SCHOOL DISTRICT (WCUUSD)

The relatively new WCUUSD consists of the elementary schools of the five towns of the former Washington Central Supervisory Union (Berlin, Calais, East Montpelier, Middlesex, and Worcester) and U-32 Middle/High School. A single school board with representatives from the five towns is responsible for the entire pre-K through 12 school system. Now, all voters from the five towns elect all members of the board, as well as a moderator, clerk, and treasurer for the school district.

In keeping with time and space limitations, the Signpost will continue to publish statements from those running as board members from East Montpelier, as well as the non-townaffiliated positions of moderator, clerk, and treasurer. It is hoped that information on other candidates will be available on the WCUUSD website.

WCUUSD SCHOOL DIRECTOR (from East Montpelier): *one 3-year term*

School directors are responsible for managing the general affairs of the school district by developing policies and hiring able administrators to assure the soundness of the physical assets as well as the educational content and methods presented in student classrooms. They are responsible for convening school district meetings.



Flor Diaz Smith: Since moving to Vermont from Guatemala City in 1997, I have been dedicated to serving our community and volunteering in our schools. In 2009 I became a citizen in order to run for the East Montpelier School Board. I value and understand the importance of collaboration among all members of the school

community and the townspeople we serve for the common goal of supporting the best educational outcomes for all our kids. It is not easy to represent all voices in our five towns, but I am a patient listener and a good communicator. I believe education is the most important gift we give our children, and a strong public education is the basis of our

Resilient Roads Team Completes Arbor Day Project

ast spring, East Montpelier's Resilient Roads Committee (RRC) was awarded a 2021 Arbor Day Tree Planting Grant, one of 16 administered by the Vermont Department of Forests - Parks and Recreation. Time having taken its toll on the trees in East Montpelier Center, home of the historic Old Meeting House and the Parley Davis House, the RRC decided to apply the \$1,100 grant to the section of Center Road between Brazier and Bliss Roads. The team engaged with residents in the area on several occasions to plan what work should be done and the placement of new trees.

Based on information from the Department of Forests & Parks and discussions with professionals in Vermont's nursery industry, the RRC decided to purchase seven sugar maples (Acer saccharum cv. 'Fall Fiesta') from the E.C. Brown Nursery in East Thetford. The

'Fall Fiesta' cultivar has been noted to be more vigorous and symmetrical in growth than the species, and its thicker leaves have been reported to give it good resistance to leaf scorch. It is also more heat, wind, and drought tolerant—characteristics the team hopes will make them more resistant to pressures from climate change (and road de-icing salt).

The first Arbor Day in Vermont was proclaimed by Governor Samuel E. Pingree in 1886, and the Vermont legislature has designated the first Friday in May as Vermont's Arbor Day. As was the case with so many activities, the Covid-19 pandemic disrupted normal nursery supply channels, making even sugar maples difficult to obtain this past spring. That, coupled with unusually hot and dry conditions in early summer, resulted in tree planting being deferred until September. Fortunately, the terms of the grant allowed leeway in planting, so the mission was completed successfully within the required time.

In preparation, the town's highway crew delivered a load of wood chips to the Center to use as mulch on the newly planted trees. Over a dozen community members

participated in planting day activities, either siting, planting, amending the soil, mulching, staking or—equally as important—providing coffee, cider, pastries, and lunch for the entire group.

The RRC team currently includes Jeff Cueto (chair), Paul Cate (EM tree warden), Mark Lane, Guthrie Perry, and Steve Justis. Other recent RRC activities include developing a town ash tree management plan and a shade tree preservation plan; overseeing protection of or removal of hazardous/at-risk ash trees along town rights-of-way (ROWs); planting red, swamp white, and English oaks on the U-32 campus; and removal of invasive species in or near town ROWs.



The EMES Five-Star Restaurant

We now know that an in-person Town Meeting won't happen in 2022, so we won't be enjoying potluck lunch in the EMES cafeteria. Annie Finnegan and Jen Wiater have, for many years., guided us through serving



those wonderful lunches. But they can be found at EMES—every day—on the job. Their job is to plan, cook, and serve breakfast and lunch to East Montpelier School students: breakfast for 65 or 70 and lunch for around 120 children. Essentially, they run a restaurant

out of the school kitchen, just the two of them.

They make almost everything from scratch every day. Operating on the premise that children need healthy choices, they set out quite a variety of offerings, including vegetarian and gluten-free items. Breakfast will have three to five options, including cereal, muffins, yogurt parfaits, and one hot item, such as scrambled eggs. Lunch includes

a hot item and a sandwich-of-the-day. Hot items might be chicken and veggie stir fry, pizza, or meatloaf. EMES boasts the only salad bar in the district, offering fresh vegetables and fruit as well as proteins such as cheese or smoked ham. "What is the most popular lunch item?" I asked. "Brunch-for-lunch," they agreed, with waffles as the centerpiece.

Every day is different. The lunch menu is sent to classrooms and is also posted on the EMES website. After teachers submit student orders, the food is prepared. Unlike most restaurants, this one has a budget of \$2.50 to \$3 per person for lunch, reimbursed by the USDA, with all students getting free food during Covid. On remote schooling days, Annie and Jen make up individual bags that are delivered to students' homes.

Amazed, I ask how they pull all of this off. They laugh, "We work really well together. It's like a dance. Sometimes it's a cha-cha and sometimes it's a waltz." Besides the daily dance, these remarkable women provided a Harvest Feast for families in the fall, staying late to make up meals for families to take out. Added to that, they also made a special holiday meal for the children on December 21st. Most recently, they gave out take-out pizza kits.

Although we citizens are not feasting together on Town Meeting Day, our young children do that every school day. Heathy choices, homemade food: it's an ongoing labor of love from Team Annie and Jen.

Seasonal Recipe Sugar on Snow

PREPARE: Plan to have packed containers of snow. Ideally, it will be granular snow, also known as corn snow or springskiing snow. But any will work, as will ice shavings done with a machine. You will need a bowl of it indoors when cooking the syrup. Use a nice quality of syrup, either Golden Color, Delicate Taste (Fancy), or Amber Color, Rich Taste (Medium Amber). Plan on 1/4 - 1/2 cup per person.

COOK: In a heavy pan, heat syrup to 22° above the boiling temperature of water for your setting, most likely 234° F. Watch the syrup carefully, especially when it starts to boil/foam. You can use a tiny dab of butter to settle it down. When it

reaches 232°, spoon a bit of it onto the snow in the bowl. When it no longer sinks in but stays on top and is like a soft taffy, it is ready to serve.

SERVE: Put it into a ceramic pitcher to share or in ceramic coffee cups for each person. Serve with plain raised doughnuts, dill pickle spears, and cider, coffee, or milk. If this can be served outside on a nicer spring day, so much the better! Some folks like to dip their doughnut right into the hot syrup, skipping the snow!

If there is syrup left over, it can be cooled and reheated for another gathering, or put into a sturdy mixing bowl and stirred with a strong spoon until it crystalizes. This can be spread on toast.


