THE WOMAN AT THE TOP OF THE SIGNPOST: JEAN M. CATE, 1924-2004

Sandal Cate

She was often called one of East Montpelier's town mothers. Who could have expected that a little girl born 80 years ago in the teeming city of Tokyo, Japan, would find her happiest and most rewarding days in East Montpelier, Vermont, trying to serve others in our community?

Jean Cate and her sisters, Ruth and Dorothy, had a most unusual childhood for girls of those times. Their parents, Reverend and Mrs. Clifford Stetson, were Vermonters who volunteered to serve as missionaries in Japan during the 1920's and early 1930's. Fortunately for Jean's family, her father was a careful photographer. He took many pictures of their life in Japan, and those pictures eventually ended up back in Vermont. Additionally, he took the time to mount them in the classic black paper photo albums of the times and carefully inscribed them in white ink. Jean's family has delighted in looking at those incredible pictures that tell so many stories of her life as a child in Japan.

In addition to experiencing the beauty of the Japanese culture which Jean continued to study her whole life, very early on she was exposed to the richness of community that comes from serving others in some public capacity. While her father tended to his vocation, Jean's mother served also as a missionary's wife in various capacities. Margaret Stetson took charge of running a kindergarten for her girls and several children in the neighborhood. Astonishingly enough, Jean and her two sisters had the good fortune to revisit Japan 55 years later, and they held a kindergarten reunion with some of those very same students! So, both her early life in Japan and observing her parents serving in various roles in the community influenced Jean in all that she did in her later life.

As a much expanded family, the Stetsons returned to America when Jean was nine. They continued to live the life of a minister's family in the northeast. Eventually Jean graduated from Buffalo (NY) State College second in her class. After graduation, she married Weston Cate, Jr., in 1944, and they both chose teaching careers in Vermont.

TOP OF THE SIGNPOST

On a perfect Vermont summer evening, we sat down to dinner with our dear friends on their screened in porch. We could barely talk fast enough to catch up on all the family news. We've known each other for over 30 years, are Godparents for each other's children, played together on hockey teams and tennis teams and just know we'll always be as close as friends can be. Since they'd moved to New York, our times together have always been special, and we'd been looking forward to this evening for several months.

By about dessert time, our appetites for food and family news were pretty well satiated. So, moving the conversation along, someone asked, "Have you seen the movie?" We all knew without asking for clarification "the movie" was Fahrenheit 911. If you haven't seen it or heard of it, it's a highly charged view of the current administration. (I'll put the reader's mind at ease by saying up front this is not a piece about "the movie.") Based on the reactions around the table, it became clear very quickly we were coming from different places politically. In fact, we were all relieved when someone said, "I guess we just better not talk about this. I can't talk about it with my kids either."

We moved on. The rest of our time together was delightful, and we made a date for our next visit. In the car on the ride home, I considered our dinner conversation, or I should say our lack of conversation, when the topic turned to politics. It seemed rather odd to think there was a topic we four best friends felt we couldn't discuss. What's that about? Did disagreement threaten our friendship?

I've been thinking a lot about these questions throughout the final days until the presidential election. We all hear and read so many different opinions about a wide range of important topics: the environment, the economy, education, health care, Roe v. Wade, same sex marriage and foreign policy to name a few, that it goes without saying we won't agree with everyone on every core issue. But is avoiding topics of disagreement, the way we did with our friends, really what we want? I have to say no. I think we have to work hard at talking and listening to each other as a way of gathering information in order to make our own informed decisions.

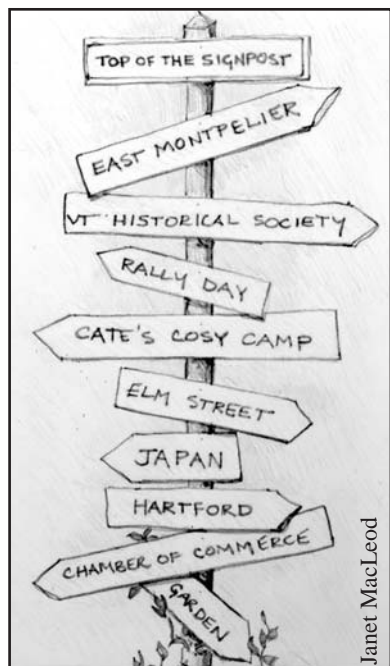
Many of the issues are so complex it's hard to know or understand all the information necessary to make a decision, much less talk about it. And yet, the best way to gain wisdom is to read and listen to discourse from as many sources as possible. If we decide to only listen to those with whom we agree, we're turning away from opportunities to increase our understanding and make more informed decisions.

As far as getting angry or upset at different opinions or the people who espouse them, I can't think of a bigger waste of energy. We don't have to be disagreeable to disagree. In fact, what we need is to depersonalize reactions to differences. Avoiding the discussion of core policy issues is a missed opportunity; not an opportunity to change someone else's opinion as much as a way to form our own. What is called for is for all of us to look inward and choose those issues that touch our core and learn about them so the knowledge can be shared with others who want to learn. Garrison Keillor wrote, "...the hottest place in hell is reserved for those who remain neutral in time of crisis."

Remaining neutral means remaining ignorant. With knowledge comes caring and caring leads to involvement. Our political structure works best when the most people participate. Our involvement is what pushes the system to reflect what we the people want for our country. In countries where information and participation are limited, the people are victims at the mercy of a few. Our ability to access information is astounding. We need to take advantage of this and embrace different opinions as a form of brainstorming to get the best ideas about the important issues. No, our friendship should not be threatened because we've arrived at different conclusions to the same questions. Our friendship should be strengthened because we shared our ideas about issues that matter to us.

I came across the following quote in the Marriage Announcement section of the New York Times. One couple's vows included the following words, which, if we all followed them, would lead to deeper friendships and a broader perspective on important issues. "I promise to listen to you even when we passionately disagree, and I promise to debate with you, even when we completely agree." What a good idea.

They first taught in Ludlow, then in White River Junction, though Jean spent most of her time raising their three sons on a farm in Hartford.

What brought Jean and Weston Cate to East Montpelier? Their careers brought their family to Montpelier for the next 20 years. But they longed for better gardening soils and the challenges of a country home. When Fox Run Farm on the County Road came up for sale in 1977, they jumped at the chance to relocate. Each move with their family also brought them closer to a

very special place in both their lives: a cozy summer camp on Nelson Pond in Calais where Wes' parents had honeymooned, where Jean and Wes honeymooned and where their son, Paul and his wife, Sandal, also honeymooned! The farm provided their family with food as well as products for the Farmers' Market for the next 20 years. And they now lived just that much closer to camp!

Jean and Weston both worked in public jobs all their lives. Teaching led to other job opportunities. Jean managed the Montpelier Chamber of Commerce in the 1960's and later spent 16 years as a registrar for the Vermont Historical Society. Serving the public was just in their very nature. Lucky was our town when these two civic-minded folks settled here. After getting the gardens in shape, fixing up various barns for chickens, pigs and beef cows, Jean and Weston started to focus on service to our town. Weston served as Town Moderator, selectman and on committees for the U-32 School Board, while Jean got interested in the town planning forums.

They both were keen observers of the needs of the community at various levels. From Jean's perspective, she felt the townspeople needed more avenues to share their strengths, to get to know one another better and to celebrate the beauty of the town. With many others interested in these same goals, Jean devised two methods to accomplish them: establishing a community newspaper and holding a town celebration. Perhaps it is

for her work in these areas that Jean will be best remembered. She agreed to sign on as the publisher of *The Signpost*, and she also spent innumerable evenings meeting with insightful town members creating the fun-filled day we now call Rally Day.

Jean was rarely daunted by a project. Her family has witnessed her incredible drive and vision to renovate several old Vermont houses. She worked to turn each one into a warm welcoming home which community members often visited for a comforting cup of tea or coffee, her nutritious and tasty cookies and a stimulating conversation around any number of current topics. Jean had the uncanny ability to include everyone in a conversation, in signing them up for some aspect of a project and by drawing on their strengths to encourage them to contribute to the wellbeing of others. She devoted her time to multitudes of projects both big and small, and she knew how to make it seem like fun! As her daughter-in-law and nearest neighbor over the past 25 years, I witnessed this time and time again. All members of a group in which Jean participated knew that Jean would pull her own weight, and as members of that group, all were involved soon in doing their fair share.

For the past several years, Jean seemed to be just about everywhere in the life of the community, yet it wasn't hard to find her at home, working in the garden, organizing family genealogical files, and telephoning to make sure ideas and plans were being carried out according to schedule. For her intense devotion to her family, her neighborhood, her church, as well as school and town events, many of us will long be grateful. Our town was lucky that this woman, born thousands of miles away in Japan, eventually made her final home in East Montpelier, Vermont. She will be remembered for many years into the future of our growing and friendly town.

Sandal Cate married into the Cate family almost 30 years ago, and she never wanted to trade her in-laws with anyone else! Paul, Wes and Sandal continue to run Fox Run Farm with other family members pitching in. Call to visit!

RABBITS

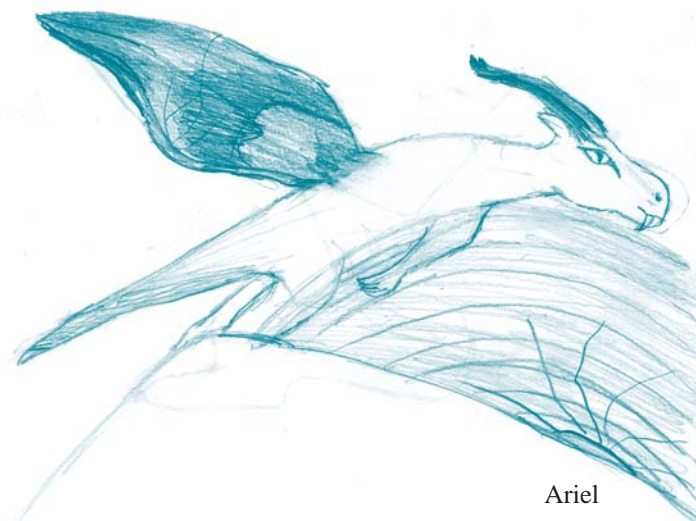

COMMUNITY CONNECTIONS

East Montpelier Community Connections recently completed its third year of after-school, vacation, and adult programming. Community Connections started in 2001 with a federal 21st Century Community Learning Center grant. This year, we are using a combination of the last of the grant money, user fees and other funding sources as we work toward a sustainable program. While the main focus of EMCC has been programs for kids, we have also offered a variety of adult and family programs ranging from cooking and computer courses to dance, yoga and photography. One popular event has been the annual wreath-making workshop where about 40 local residents come together and turn a pile of donated fir boughs into beautiful wreaths. Another popular activity is the scrap-booking group led by community member Patty Connor whose loyalty to the craft is legendary. Adult and family courses vary in price with some being free or donation-based, while others charge a fee. This year, due to tightened budgets, participants are required to pay for the entire session in advance to guarantee there is sufficient enrollment to allow the class to run. Information about these classes and events goes out through student packets, school newsletters, posters and advertisements in *The World* and other publications.

EAST MONTPELIER TRAILS

For the last few years, the trails group has taken a hiatus from major projects, working instead on some longer-term planning and opportunities. One of these opportunities, the conservation of the Pratt property encompassing Mallory Brook, is close to reality. After much hard work by the Trust for Public Lands, our trails group and generous support from many people, the closing is now scheduled for early October. Integral to the terms of the conservation easement will be the construction of about two miles of trail roughly parallel to the brook, with spur trails. This segment will be a significant step toward our ultimate goal of a nearly 20-mile loop through the Town, including the Cross-Vermont Trail and City of Montpelier trails on the southern edge. We hope to begin construction on the Mallory Brook section soon after alignments are established.

We have also been moving forward on completion of the Cross-Vermont Trail segment through East Montpelier to Plainfield. This will largely follow the route of the old railroad bed, though it is not quite that simple. From Montpelier (Garrison Hill Rd.) eastward, we need to negotiate the route with utilities owning the railroad bed and/or easements along the Winooski River, put a new bridge across the river (hopefully using the existing abutments), then sandwich more than a mile of trail between the river and US 2 before crossing US 2 near the Industrial Park. And that's just the first mile and a half (out of 5 miles). This summer, we had two weeks of help from the Youth Conservation Corps who cleared the railroad bed on the sections we can still use along the river.

Fall is a great time to get out on the trails. Enjoy the scenery, and please respect the property owners whose land you are crossing by staying on the trail.
