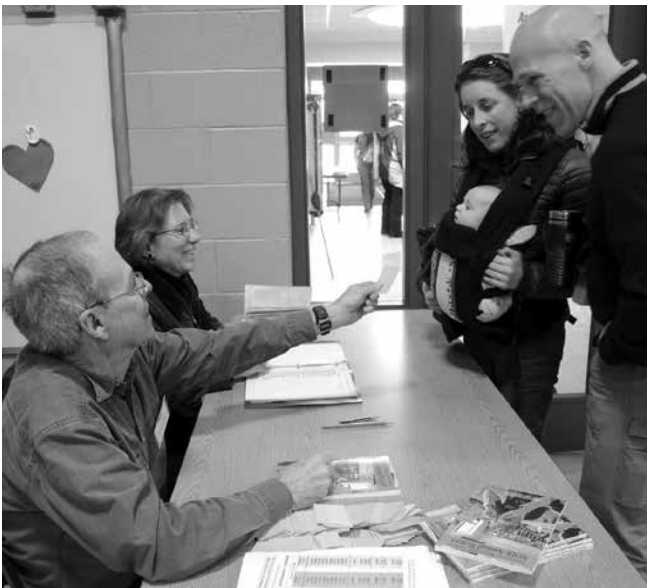

Top of the Signpost 2016 Town Meeting Preview

Town Meeting generates excitement in East Montpelier as neighbors gather to eat, socialize, and, of course, discuss and vote on issues important to the town.

There are three particular issues that will be brought up at this year's meeting that will, no doubt, elicit interest and discussion. Citizens will be asked to vote on 1) whether to disband the current Recreation Board as a town entity and transfer its responsibilities to an independent non-profit organization; and 2) whether to add \$10,000 to the Land Conservation fund. The background information on both these issues is included on pages 12, 41, and 44 in the Town Report which each household receives.

The third issue concerns the recent purchase of the so-called Winston/Silberberg property, the 48-acre parcel (the remnant of the old LaPerle farm, including the old farmhouse) located at 3035 US Rte. 2. The property runs from US Rte. 2 to Marc Fontaine's saw mill property on VT Rte. 14 N and straddles Sodom Pond Brook. The selectboard will lead a discussion of possible uses for this land and will ask for seven volunteers to serve on a committee which will develop a plan of action for the property. The background story on this issue can be found on pages 12 and 46 of the Town Report.

Descriptions taken largely from the VLCT Resource Manual and Vermont Law

Town and School District Moderator

(elected separately)

one 1-year term

The moderator is the presiding officer of municipal and school meetings and shall decide questions of votes taken, except if Australian ballot is used. The moderator shall preserve order in the conduct of business and meetings.



Michael Duane: I am running for re-election for the positions of Town and School District Moderator. My wife, Ellen, and I have lived in Vermont since the mid-1970s, and have been residents of East Montpelier for over 30 years. I served as President of the Washington Electric Co-op from 1991 to 1998, during which time I

presided over the monthly and annual meetings. I have also served on the Town Ancient Roads Committee, a town committee to explore the effect of land conservation on the property tax rate, and more recently on the town Charter Committee. I am also a member of the East Montpelier Historical Society, and was a member of the board of the Hunger Mountain Coop from 2008 to 2011. As Coop president during my final year, I presided over the monthly and annual meetings. I would be honored to serve again as the East Montpelier Town and School District Moderator, and I hope my experience can be of some service to our town.

Selectboard Member

one 3-year term, one 2-year term

Selectboard members are responsible for general supervision of the affairs of the town and are responsible for seeing that all duties, not assigned by law to any particular officer, are carried out. The selectboard convenes town meetings and may enact ordinances and rules that regulate areas such as roads, traffic, waste disposal, animals, and nuisances as examples.



Carl Etnier, 3-year term: Every week on my WGDR radio program "Relocalizing Vermont," I explore issues related to building more resilient communities. I'm pleased to live in and serve a Vermont community that builds the strong bonds that make for resilience through neighborhood potlucks, community

sing-alongs, our discussions on Front Porch Forum, the work of the historical society, a town-wide network of trails, and much more.

I have served on the Selectboard for the last five years. The Selectboard has balanced keeping tax rates in check and predictable, while taking advantage of unpredictable opportunities that come our way. A new capital budget process, instituted in cooperation with the Planning Commission and the Treasurer, has helped us foresee what spending is coming up and plan to space it out over a reasonable time.

We have also been able to take advantage of the opportunity to buy 48 acres in the village when it was put up at auction. This is a property that can help the town shape the future of its village, and we were able to acquire it at significantly less than an appraisal we commissioned said it was worth. We look forward to continuing conversations with townspeople about how best to use the land.

I have been proud to work with the team on the Selectboard, in the town office, and on the roads, and to represent the people of East Montpelier. I'm asking for another three years on the team.

Gene Troia, 2-year term: No candidate statement.

Lister

one 3-year term

Listers are responsible for determining the value of the real and personal property in town. This is the value the selectboard or the town will use to set a tax rate necessary to raise the money to operate the town in the next year. It is also the basis for the determination of the property wealth of the municipality for purposes of setting state education property taxes.



Chris Racanelli: I have more than 30 years of experience with the real estate business and am familiar with appraisals and valuation. I also worked in Social Services for many years and developed good listening skills. I am friendly and easy to talk to.

I have lived in East Montpelier since 2010, and my wife Susan and I feel fortunate to call it home. My neighbor, Paul Erlbaum, introduced me to Green Up Day and I have enjoyed the tradition of this day and sense of community it fosters. I served as Co-coordinator for a few years, before accepting the role of Green Up Day Coordinator in 2014.

I look forward to serving the Town of East Montpelier and hope you will vote for me on March 1.

Auditor

one 3-year term

Town auditors are responsible for examining and adjusting the accounts of all town and school district officers and all other persons authorized by law to draw orders on the town treasurer. Secondly, they are to report their findings in writing to the legal voters of the town presenting an easy-to-understand picture of the town's finances.

Deborah Fillion: No candidate statement

Collector of Delinquent Taxes

one 3-year term

The CDT is authorized to work with delinquent tax payers to arrange payment due to the town and is authorized to collect penalty and interest and sell property at auction if necessary to assure settlement of the town's claim.



Karen M. Gramer: I have been your Collector of Delinquent Taxes for the past eight years and believe I have served the taxpayers of East Montpelier well. I successfully collected delinquent taxes due the town of East Montpelier and have initiated and conducted tax sales when necessary. My unique work experience as

a real estate paralegal for over 20 years, interacting with the public and working in many of the town clerk's offices in the State of Vermont, have given me the knowledge to thoroughly understand the tax collection process. After the Treasurer submits the warrant to me for collection, I notify taxpayers monthly via US mail of their delinquent accounts. I also speak or meet with them frequently in order to work on timely payment arrangements balancing the taxpayers' ability to pay along with the town's need for revenue. My tax collection policy is distributed to delinquent taxpayers in order for them to have a thorough understanding of the tax collection process. My detailed collection reports are submitted biweekly to the town, and frequent meetings with the treasurer and monthly reconciliations ensure accurate financial calculation and recordation of delinquent taxes.

My years as Collector of Delinquent Taxes for the town have been a mutually successful experience, and I look forward to continuing to serve the taxpayers of East Montpelier.



First Constable

one 1-year term

East Montpelier has voted to prohibit constables from exercising any law enforcement authority. The constables serve as animal control officers and may be called on to serve civil or criminal process and to aid first responders when necessary.



Sandy F. Conti: I have served as the Town's First Constable (and Animal Control Officer) for nine years and still find it interesting and at times challenging. I enjoy the opportunity to give back to the town that I have called home for more than 20 years.

I would appreciate the opportunity to serve as the first constable for a tenth term.

one 5-year term

The cemetery commissioners are responsible for the care and management of the Town's cemeteries.

Planning Commissioner

three 3-year terms; one year of a 3-year term

The Planning Commission is responsible for preparing and maintaining a current Town Plan and Zoning regulations. It reviews significant developments and makes recommendations on issues including land development, transportation, economic and social development, historic, wetland and scenic preservation.



Norman Hill, 3-year term: I am seeking another term on the Planning Commission. I moved to East Montpelier in 2004 after retiring from the photojournalism staff of ABC News in Washington, D.C. Since then, I have served the town several ways including the Cemetery Commission as assistant groundskeeper, the Charter Committee, Planning Commission, and Development Review Board. I enjoy being involved in the town government process and look forward to helping develop the Village Master Plan, the major focus through 2017. Another timely issue on the agenda is the PC's opportunity to seek town intervening status for commercial solar development. The status provides East Montpelier input into the development whether or not the town supports a particular project.

I serve on several committees at The Old Meeting House, and my hobbies include reading (presently hooked on David Baldacci), tennis (wish I was as good as I think I am), and baking sourdough bread, which you may have tasted at one time or another. I appreciate the opportunity to serve East Montpelier and thank you for your vote.

Kim Watson, 3-year term: Thank you for letting me support the community as a Planning Commissioner and a member of the Development Review Board (DRB) for the last nine years. I wish to continue in that role for another three years and I would appreciate your vote to continue as a member of the Planning Commission. I still

have a strong interest in zoning and planning in our community. While I support the zoning regulations, I and our fellow commissioners are open to interpreting and changing aspects of the regulations and town plan to encourage development. I believe that people have a right to do what they want with their property while ensuring that land and property values in East Montpelier are preserved. I have lived in East Montpelier for over 30 years and worked for the last 35 years in the environmental chemistry field in health and safety and quality assurance, balancing environmental issues with business strategies. I currently work as a Quality Assurance Manager and Health and Safety Officer for Stone Environmental in Montpelier. I also enjoy living and working on the McKnight Farm on Snow Hill Road selling certified organic beef and raw milk.



Ray Stout, one year of a 3-year term: I moved to East Montpelier with my wife and children a year ago. For the past couple of months I have been serving the residents of East Montpelier as a Planning Commissioner in an interim role. During that time I have found the work interesting and rewarding and I look forward to the opportunity to represent the interests of town residents in the upcoming year.

East Montpelier Planning Commission

Thanks to a recently awarded Municipal Planning Grant, the Planning Commission's focus in 2016 will be the creation of a Master Plan for East Montpelier Village. We will be developing a detailed plan and supporting zoning regulations designed to create a vital and attractive business and residential center. The grant will allow us to hire the professional expertise of the Central Vermont Regional Planning Commission (CVRPC). We will be asking residents and business owners for their participation and ideas about which areas should be included in the village, whether different parts of the village might have different characters, and how infrastructure investments and zoning can help support the creation of a vital and attractive village center.

The Planning Commission will also continue to look at other parts of town and how we might help create new centers, such as around Gallison Hill, or encourage desirable patterns of growth. Like other communities, East Montpelier is beginning to experience developer interest in commercial-scale solar projects. We will be involved in these applications to ensure the best results for the town including creating screening and siting guidelines. Residents can read about the Planning Commission's 2015 endeavors in the Town Report.

The public is always welcome to attend our regular meetings on the first and third Thursday of each month, starting at 7:00 p.m. in the municipal building.

Community Projects: Maybe the Jean Cate Community Fund Can Help

"A community is strong when people have lots of opportunity to work and play together." –Jean Cate

If you are planning a project that will pull together the people of East Montpelier and enhance our sense of community, perhaps the Jean Cate Community Fund could help you with seed money, matching funds, or a piece of the cost of the project. The purpose of the fund is to encourage and support community-building activities in East Montpelier.

Following Jean Cate's death in 2004, her family decided that memorial donations that had been contributed by friends and family would honor Jean's community spirit by setting up a fund to be used for community activities. Jean Cate had been the spark that started Rally Day and the *Signpost* newsletter. Her husband Wes Cate brought together a committee to administer the fund, and it continues to function though Wes has also passed away. Recently the Jean Cate Fund has contributed to Front Porch Forum and the Green Up Day Lunch. In the past it has helped with orientations to Town Meeting for new residents, putting together a booklet "About East Montpelier," a celebration of retaining the Coburn Quarry as a swimming hole, distributing bulbs for the Daffodil Project, encouraging neighborhood potlucks, and organizing "Informatories" about East Montpelier issues. The fund also provided seed money for the East Montpelier Senior Living Initiative's early mailings regarding senior housing in town.

Making Maple Syrup at Fox Run Farm

Just over 35 years ago Paul and Sandal Cate built a log-cabin style sugarhouse on the County Road at Fox Run Farm. Every spring since then they've used sap buckets and tubing on the farm and on neighbors' trees to gather, filter, and boil sap from about 160 taps to produce their syrup for home use and to sell to neighbors. Paul learned to sugar down the road at the Morse Farm, and he taught his wife, his sons, and now is teaching his grandsons all about sugarin'. It's hard work but it's fun, and maple syrup is unmatched in the sweetening realm!

Sugaring is best learned from helping another sugarmaker. Then, one has to decide if they have the time, energy, money, and trees needed to start in on one's own operation. Some families boil sap from a handful of trees while other sugarmakers have operations covering many acres of land and requiring lots of equipment in good working order. Vermont regulates the grading of syrup no matter how large or small one's operation may be. If you're going to sell maple syrup, it has to meet the grade. The Vermont Maple Sugar Makers Association is the professional guide for assistance in all things maple.

The Cates enjoy hosting sugar-on-snow parties for family and friends at least once each season. At that time of the year everyone is ready to be outside enjoying the thawing days of



spring. The maple syrup is cooked down to a higher density than plain syrup, then gently poured over hard packed "sugar snow". It's chewy and tasty, served with pickles and doughnuts. Watch for steam coming from a sugarhouse near you soon!

1 cup sugar	Add 3½–4 cups flour to make
2 eggs	the dough stiff enough to
1 teaspoon melted lard	handle. Cut out all the dough
(may substitute butter)	before you start to fry the
2 teaspoon cream tartar	donuts. Lard is best for frying
1 cup sweet milk	— about 360-365°
1 teaspoon vanilla	
1 teaspoon soda	Great with sugar on snow.
a little nutmeg	
a little salt	

The recipe comes from the North Montpelier Friendly Circle cook book put out by a ladies' group associated with an area church. Julia Hollister Clark was born in 1870 and lived until 1939. There is no date in the book, but we think it probably dates from the 1920s.

East Montpelier Trails

2015 was a busy year for East Montpelier Trails. We were thrilled by the support shown for the trails at Town Meeting with the community vote to approve our request for \$4,000. These funds were put to good use on several projects with the primary focus being on two sections, Mallory Brook and the new T. Clark connector to U-32.

On the Mallory Brook trail you will see new trailhead signs at both the Johnson Road and the Cherry Tree Hill Road entrances, and newly improved, clearly designated parking areas. Work has also been done extending the trail southward with the addition of a new bridge and a hardened surface for multi-purpose use. A big shout out “Thank You” to Greg Western and all of his numerous volunteers from Volunteers for Peace, Norwich University and the VYCC!

On the T. Clark trail, the funds were used to purchase materials for a crucial bridge crossing and boardwalk over a somewhat large gully. This project was exciting because it involved collaboration with the U-32 athletic department, assistance from Eagle Scout project leader Henry Hoffert, and the donation of invaluable time and expertise by “Timber and Stone” trail builders Josh Ryan and Gordon Adams who spent more than two and a half days on this major construction. At least 65 volunteers took part in this endeavor, which will greatly benefit East Montpelier and U-32 together. It is important to

note that while the trail is passable, there is still need for the installation of a boardwalk to protect the wetland, so please use the trail with discretion and please no bicycles at this time.

With a new trail easement on the Ormsbee property, Sandy Woodbeck and a crew of the East Montpelier Gully Jumpers cleared the snowmobile section of the right-of-way through this property.

We are currently scouting a route to connect the Mallory Brook trail to a safe place to cross Towne Hill Road and connect to School House Road and subsequently the T. Clark trail. This as-yet-to-be-determined route will likely need substantial work and another bridge eventually.

In other locations throughout the town, you will notice new trail signs in critical locations to address concerns regarding being able to follow the trail at any time of the year. A big thanks to Rick Hopkins for his diligence on these projects.

Once again, we greatly appreciate the support that the townspeople have given us to make progress on these projects with much more in planning stages. 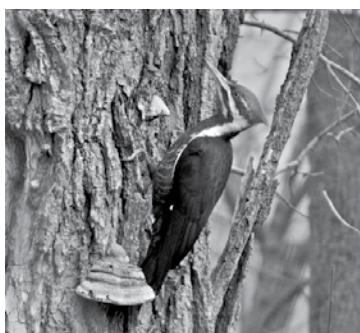

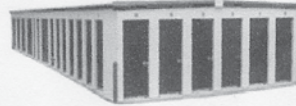
