## FROM FLOWERS TO FOUR CORNERS: RUTH FROST

On Mother's Day I walked past Ruth Frost's house on Kelton Road and admired the flowers: bloodroot, trout lilies, and lots of daffodils. When the warmer weather arrives, Ruth's many perennials will bloom to provide color into the fall. Ruth and her husband, Dr. Kendal Frost, are the fourth owners of the antique brick cape which overlooks fields with a mountain range in the distance. Behind the Frosts' house are more fields and a magical red pine plantation. The Frosts generously allow their neighbors to ski and snowshoe through their property where an abundance of wildlife resides.

This story begins in 1961 when Ruth and Dr. Frost left Connecticut (where Ruth was born and raised) to live in England for three years while Dr. Frost was employed by the National Health Service. This was a great experience, but the weather was atrocious. The weather reports would predict "bright intervals" which meant the sun would shine for about ten minutes then the gloomy, dark clouds would return. During vacations the Frosts toured Europe and developed friendships that still flourish today. Their daughter Hilary was born in England.




Although Dr. Frost was willing to stay on in England, Ruth was ready to see the sun on a more regular schedule, and the family moved to New York in 1964. Dr. Frost took a position with the Albert Einstein College of Medicine. Timothy and Christopher were born in New York and completed the Frost family.

After visiting friends in Vermont, the Frosts knew where they wanted to raise their family. In 1966 the Frosts moved to East Montpelier, and Dr. Frost became central Vermont's first orthopedist. Ruth's home reflects her love of 18th century antiques and needle arts. She takes quilting and needlepoint classes to meet other people who share her interest. Ruth is passionate about perennials and believes that gardening provides wonderful therapy.

For years Ruth's main responsibility was her family life. She participated in 4-H, Cub Scouts, and started the ELF Program at the Elementary School. Ruth feels strongly that we all have a responsibility to serve our community, and she has served on boards both locally and statewide. Ruth's strong interest in human services led to her appointment as the first volunteer Executive Director of the Vermont Association for Learning Disabilities. Ruth has also worked with the Hospice program.

In 1979 Ruth gained another son. Mohsen Javadabadi Falahi, a teenager from Iran, came to the Frosts' home for Thanksgiving and stayed for five years. There was a revolution in Iran at that time that prevented Mohsen's return to his home country and he never went back. Mohsen attended U-32, then Vermont Technical College. A few years ago Mohsen had a reunion with his father in Toronto, and in March both of his parents came to his home in Plainfield and are here for an extended visit. Mohsen hadn't seen his mother in 20 years!

Getting to know Ruth Frost for this *Signpost* interview has been fun and informative. As an incoming Four Corners School Association Board Member, I learned the



### MORE PATIENCE! BETTER ROADS!

The Selectboard signed a contract with Pike Industries, Inc. for the 1997 paving project. Roads included are County Road, Center Road, the older mile of Towne Hill Road, Vincent Flats and Quaker Roads. The project is being funded with monies approved at the 1997 town meeting.

The Road Department and Willey Excavation have been clearing ditches. The reclamation of the existing pavement will begin in late June and continue into July. New pavement will be laid shortly following the reclamation. The Selectboard intends that the time between grinding the old pavement and laying the new to be long enough to help compact the base but short enough to minimize inconvenience. It is hoped that all work will be completed by the end of August.

## SPECIAL INVITATION FROM THE OBC CHOIR:



## ELLIOTT MORSE: OF "ELEPHANT TUBES" & BUGS

Back in the early sixties Warner Shedd didn't have the slightest idea he was partially responsible for the creation of a thriving business when he asked his neighbor's son, Elliott Morse, if the young lad could somehow fix his ailing Volkswagen Bug. The nearest Volkswagen dealer was in St. Johnsbury, a long ways to go for minor repairs. Elliott fixed it, the first of hundreds of Volkswagens which sooner or later rolled up to the Morse Garage on County Road, where Elliott, his wife Florence, and of late years, their son Brian have operated a highly respected garage.

Elliott decided early on that he preferred mechanical work to farming. After finishing school, he went to work for Twin Town Motors in the days when it was possible to purchase a new Bug for \$1300. After three years there, he and Florence decided to launch out on their own, setting up shop in a building next to his grandfather's former Allis Chalmers dealership across from the home place on County Road.

A year later on October 6, 1966, in an early snowstorm, the young couple's tiny garage burned to the ground. They lost everything, including several cars which were being repaired. A week later, the town's neighborly spirit prevailed, and a dozen or more friends arrived to clean up the remnants of the building and transform the old Allis Chalmers building into a usable garage. They were back in business. Thirty years later they built a new structure on the site of the original garage.

In the early sixties the Volkswagen Bug was a new kind of vehicle. Small, inexpensive to run, and sporting an air-cooled engine, it was the vehicle of choice for many young folks and area commuters. But after the first year or so there was a tendency for the heater boxes to rust out, leaving the vehicle deadly cold in wintertime. The windshield would frost over; the pedals would stick. Elliott the inventor purchased lengths of 2½" heater tube which he attached to a heat source in the rear of the car, ran it up between the two front seats, and directed it at the windshield. Many a local Bug driver remembers with great fondness the device Elliott dubbed his "elephant tube."

For many years the garage was a one-man operation, but with a strong assist from Florence. She kept the books for the firm, scheduled appointments, and if necessity required (say, when brake jobs were undertaken), she would bundle up the kids and cross over to the garage to help out. After son Brian graduated from Vermont Tech in 1987 and joined the firm, Florence went to work for the Vermont National Bank. The team approach continues. Elliott

brings years of practical experience to his work, and Brian handles the electronic side of the repair business.

For several years during the mid-sixties, Elliott would work with young folks from the Sheltered Workshop in Montpelier in an attempt to evaluate just what the residents there could do. Several who worked with him went on to mechanical careers of their own as did some of the half-dozen high school youngsters who used to work at the garage after school during the seventies and early eighties.

Busy as they have been with their business and raising their three children, Andy, Beth, and Brian, the Morses have yet devoted a great deal of time to civic work. Elliott is one of the founding members of the East Montpelier Fire Department, serving for 33 years. For a number of years he was also Fire Warden, and the Morses maintained in their home one of the three Fire Phones in the town. Before there was centralized fire dispatching, there had to be at least one person constantly within hearing of a Fire Phone to field emergency calls.

Elliott has also been a member of the Cemetery Commission for 15 years and was a Justice of the Peace for five years. Florence was active in the Fire Department Auxiliary, the PTO, and was chair of the Town Meeting dinner for several years.

The garage continues to be a busy place. Work is normally scheduled two weeks ahead except for emergencies. In a world of growing anonymity and questionable work ethics, Morse's Garage continues to offer personal attention and dependable results.
