## At Last — The Perfect Home by Michael Duane

A warm glow of lights now comes from the old brick cape farmhouse at the end of Markham Road up on Snow Hill. Built in the 1840s by a member of the Snow family, it is now the home of Paul and Elaine Manghi. The homestead had been owned by the Gallison family since the early 1900s, and, in 1964, it became the summer home of Dr. Fred and Merriam Markham of Connecticut. The Markhams became friends of the Christiansen family over the years, but sadly Fred and Merriam visited their East Montpelier home less frequently and more recently they passed away. Many of the Markhams' neighbors wondered what would happen to this beautiful house and 60 acres of land, tucked away in a quiet corner of East Montpelier. Fortunately, Paul and Elaine were at the right place at the right time, and, in 1997, their dream of living in the country came true. They have been busy ever since turning the place back into a year-round home.

No strangers to central Vermont, Elaine was born in Plainfield and grew up in Northfield where she graduated from Northfield High School. Paul's family settled in Northfield where his father taught at Norwich University. They were not exactly high school sweethearts, but Paul and Elaine were, and still are, part of a closely knit group of friends from Northfield

who have stayed in touch with one another since high school.

Although Elaine went off to UVM in Burlington and Paul went off to Maryknoll College in Illinois, they stayed in touch with each other during the school year and during summers back at home. Following their college graduations, Elaine and Paul were married in Northfield in 1969. Paul had enlisted in the army in 1968. While he served a one-year tour of duty in Vietnam after their wedding, Elaine lived in Northfield and taught school in Montpelier. After Paul's army service, they moved to Syracuse, New York, for 18 months where Paul attended graduate school in special education.

The Manghis had then wanted to travel and explore other parts of the country in pursuit of their teaching careers, but their job opportunities always landed them back in their home state. By 1974, they were back in Montpelier and their daughter Maria was born. Paul and Elaine (and now Maria) moved to North Randolph where they settled while Paul worked at Orange County Mental Health. Their son Matt was born in 1976, and while Elaine stayed at home raising the children, she began to bake bread for her family, their neighbors and their friends, then the local food co-op in Randolph, and the rest, as they say, is history.

Paul's career in the mental health field took him to a job in Waterbury so that by 1981 the Manghis moved from North Randolph to a home on Ridge Street in Montpelier where Maria and Matt attended school and eventually both graduated from Montpelier High School. Matt will now be graduating from UVM with degrees in environmental studies and art this spring, and Maria has graduated from the New England Culinary Institute where she now works in admissions after stints in the restaurant business in Chicago, San Francisco and New York.

Elaine had continued with her bread making at home while the children were in school, increasingly making bread deliveries around

## Top of the Signpost

It was Friday of the Thanksgiving weekend. Snow and mud were being stamped off boots as people entered the Old Meetinghouse, a building hallowed by a century and a half of use as a center of town functions. We were gathered there to reaffirm one of the most basic elements of small town living — that we must all participate to make the town work. Actually we were there for Roger Chapell's funeral, and to hear his family and neighbors reflect on his life was a tribute to Roger's sense of responsibility for making the town run.

It wasn't that Roger made a big thing of his service to the town, but at his death, he had served as Zoning Administrator for more years than anyone before him since the job started. We

knew him as a neighbor and friend, one who had chosen to return to his East Montpelier farm after a career spent out of state. Templeton Farm had been in his family almost since the town was settled, and Roger came back to his roots. Then he shouldered a job which might be considered one of the most unpopular in town, and carried it out fairly and even-handedly.

Now three generations of Chapells live at that corner of Center, Lyle Young, and Templeton roads. They set an example we may be proud of, both in the way they put new life into Templeton Farm, and as they take part in the life of East Montpelier. Roger left a fine legacy to the town, one that deserves our ongoing thanks.

increasingly making bread deliveries around the Montpelier area. By 1982, Paul realized it was time for a career change, and he and Elaine decided to start their own business and go into baking on a full time basis.

At first, they used the kitchen facilities at Christ Church in Montpelier, but they soon bought more equipment and moved their bakery into a small building behind the Savoy Theatre. In 1983, they moved to their present location in the big yellow house on School Street. Today their business is quite a success as they employ one full-time and six part-time employees, their bread and baked goods are distributed from Johnson to Randolph and from Waitsfield to Marshfield. In an average week, the Manghis produce 2,500 loaves of bread!

As much as they enjoyed their home life in Montpelier, Paul and Elaine always longed for a place in the country and planned when Maria and Matt graduated from high school they would make a serious attempt to fulfill their dream. They would often drive with the children through the back roads of central Vermont and explore the idea of where might the home that they were looking for be. On one such drive during the Fall in the early 1990's, they came upon a quiet, dead end, tree lined lane in a corner of East Montpelier. Elaine was so taken by the beauty of this scene that she got out of the car and took a picture of the road. She always kept that photo as an example of the type of road she would dream of living on. One eventful day in 1997, a realtor they knew had heard that a family from Connecticut was thinking about selling their summer home in East Montpelier, and perhaps Paul and Elaine would be interested in looking at the property.

Imagine the Manghis' surprise when they drove out to find the house and discovered it was the house at the end of the road in the picture Elaine had taken years before! It's no wonder when they describe their new home that they say, "We feel like we have always lived here".

Paul and Elaine can now enjoy one of their favorite sports of cross country skiing by literally stepping right out their back door, and the small raised bed garden on Ridge Street pales in comparison to their ever expanding garden in East Montpelier. They love the land that they now own, and the open fields continue to be actively farmed in hay and pasture by the Christiansens. Paul and Elaine have also made connections with the Gallison family who shared the memories and stories of living at the farm in the first half of the 20th century. Paul

and Elaine enjoy the East Montpelier community as well and are involved in the Four Corners School House Association and Historical Society.

During these darkest evenings of the year, it is nice to look down Markham Road and see the warm lights of the old brick farmhouse lit again, and know that such a nice family has found the home of their dreams.


**Note From the Listers**

## Pizza Joe's

Joe Cross operates Joe's Pizza on Route 2 in East Montpelier and Joe knows dough - pizza, cookie and phyllo. It's apparent that Joe and his wife Ceylan enjoy their work and early success. With their business, Joe and Ceylan endeavor to be a part of the East Montpelier and Plainfield communities. By donating pizzas or other baked goods, Pizza Joe's has become a contributor to local school functions, fund-raisers and organizational meetings. This generosity is important to Joe and Ceylan as it reflects their commitment to the East Montpelier community in which they and their four children reside. Though small in size, their pizza shop has a large variety of offerings and a huge personal touch. Pizzas are the main attraction, but Joe also offers other baked goods including cookies, grinders, calzones, cakes and, on occasion, a Turkish phyllo and spinach dish called borek. Ceylan has a Turkish heritage and is a significant contributor to the baking.

Joe is no stranger to the restaurant business. At the age of 34, Joe has experienced approximately twenty years in the restaurant business. Beginning as a dishwasher to earn money to purchase a car, Joe expanded his ambitions by working for a short time in Santa Cruz, California, and returned to Vermont to work at, among other places, the *Horn of the Moon Cafe* in Montpelier.

Many will recall his work at the *Maple Valley Country Store* in Plainfield, where he initiated a "pizza program" in an effort to expand the offerings of that restaurant. However, since 1990, Joe has been anxious to set up his own pizza shop in central Vermont. As of March, 2000, Joe realized his ambition by opening Pizza Joe's.

Coordinating the desire of Video Box Office/Global Gift owner Paul Shper to expand his building, Joe worked through local zoning matters, parttime employment and construction worries to open his own venture in the local economy.

Since opening, Joe and Ceylan have enjoyed a consistent success not generally realized by fledgling businesses. Joe attributes his early success to a full time schedule, hard work and the quality of his products. He spends more for quality ingredients and toppings so that the finished product reflects Joe's commitment to good food. For example, instead of using sugar to aid the yeast in the pizza dough, Joe uses fresh honey supplied to him by a resident of Elmore. Joe also utilizes pizza stones when baking his pizzas. Another component of their

success is the personal approach Joe and Ceylan offer at their business. They both take the time to share greetings and conversations with customers, suppliers and their families.

Perhaps Joe's success can be attributed to his lineage. Born in New York, Joe moved to Vermont at the age of three. His immediate family is a collection of self-starting business people. His father and mother are both proprietors of businesses in northern Vermont. His mother owns and operates a real estate business and his father has worked as a service manager and mechanic for an auto dealership. His sister and brother-in-law operate an auto parts business, and his brother provides vehicle repairs at a business known as "The Twisted Wrench." Joe's uncle provides small engine repairs, and even Joe's grandfather had ventures as a seller of wood products and autoparts. With this upbringing, Joe has developed a good sense of what is necessary to open and operate a successful community business.

Joe and Ceylan were partners for some time, and were recently married in July. They reside on North Street in East Montpelier with their four children who range in age from ten to two. They never tire of eating pizza.

Joe and Ceylan have ambitions of sending their children to college, or offering the business to any of them. Community involvement is a major component of the Cross family.
