SUE AND PUT CLAYTON - PLUGGERS FOR US ALL

Have you ever wondered about the people behind the community newsletters like the *Bus Stop Conversations*? Have you been curious about the Washington Central Friends of Education? I had enjoyed reading the articles in the past and was curious about the group that is so active in keeping the community informed. It was a lovely coincidence that I was asked to write an article about two retired educators, Sue and Put (Putnam) Clayton, who are committed to bringing schools and community members closer together. Both are active members of Washington Central Friends of Education. Sue has had leadership roles for eight years, and Put has been the treasurer. Interviewing them would be a mine of information about the many avenues that the group is exploring, so I was eager to do an interview.

Several days later, I found myself sitting at Put and Sue's dining room table. Their home is nestled in a copse of trees just past the second bend on Horn of the Moon Road. It is a lovely spot, with a view that will grow as the trees shed their leaves. It would be vividly colorful in a few days. As I looked around, evidence of Put and Sue's hobbies enticed my eye with their textures. Put is an adept weaver, a creator of beautiful patterns. Some of his dishtowels were at the silent auction this past Rally Day. Sue is a skilled potter. She uses the studio at River Street Potters, and her work is practical as well as lovely to touch. Together they have created a welcoming home, a very comfortable place to sit and chat.



Both Sue and Put are native Vermonters. Put comes from Bennington and went on to attend college at

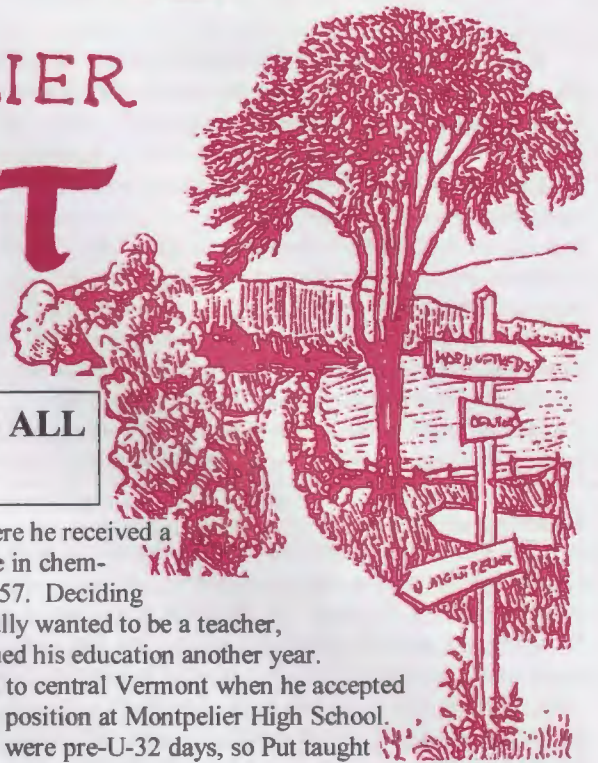
UVM where he received a BA degree in chemistry in 1957. Deciding that he really wanted to be a teacher, he continued his education another year. He moved to central Vermont when he accepted a teaching position at Montpelier High School.

These were pre-U-32 days, so Put taught math to East Montpelier residents as well as Montpelierites. He often sees his past students in the community. Sometimes they share a chuckle about the antics in the classroom. He taught mathematics for 30 years until his retirement from teaching in 1988. Put then worked at Rumney Elementary School in Middlesex as bookkeeper for several years.

Sue came from Burlington, attended the University of Chicago, graduated in 1969 and became an art teacher. Hired by Montpelier High School, she met Put there. They married and settled in East Montpelier. Sue retired from the classroom after nine years and raised their two children, as well as writing for the *Washington World*. Their elder child Rick is now grown up and residing in Williamstown. Their daughter Katie is a senior at Earlham College in Indiana.

Retirement has not slowed down their efforts to support education in their community; it has simply changed the direction of their energy. Their involvement in Washington Central Friends of Education shows the extent of their commitment. This organization has two primary focuses. First, and the most noticeable, is to keep the community informed about what is happening in our school systems. *Bus Stop Conversations* is sent out sixteen times a year in the *World*. As Sue pointed out, it is very important that the entire community be kept informed. There is a large segment of the town's population that no longer has direct involvement with the school, yet they still continue to support the system with their taxes. In order to keep healthy support, there needs to be good communication about the many things that our schools do for our children. Another method of improving communication is the phone directories that U-32's seventh graders receive each year. Originally Sue's idea, they are well appreciated by both the parents and the students. These help the transition from elementary school to U-32, making it much easier for students and parents to make new connections.

The other function of the group is to explore alternative options for funding, applying for grants, and searching out new opportunities for funding. Recently the group joined with Washington Central Supervisory Union, the Montpelier School system and the Montpelier Downtown Community Association in an effort to obtain a grant for \$1.5 million. This was to begin a new out-of-school program called Community Connections. It took over a year of fact finding, data gathering, organization and writing to successfully apply for this coveted competitive grant from the U.S. Department of Education. Through this, ten Community Learning Centers will be established, one in each of the schools of the combined U-32 and Montpelier districts. These will provide educational opportunities as well as enrichment activities after school, on weekends and during vacations. The possibilities are endless. The potential of this program is breathtaking. Both Sue and Put are excited. They hope to see the townspeople take full advantage of the opportunity. It is a new direction for education, reaching into the after-school life of the community.

Obviously this new program is a huge undertaking. It takes many dedicated people to get something like this off the ground. The executive chair, Deb Wolf from Middlesex, keeps things moving and supports project director Ginny Burley in many activities. Both Put and Sue spoke glowingly of the other board members including Kim Martin of Middlesex, Wanda Baril from Berlin, and East Montpelier residents Ginny Burley, Gary Hass, and East Montpelier principal Carol Randall, who have put so much effort into keeping the organization going. "We're always looking for new board members. It's a good group to work with," Sue assured me. "If anyone is interested in becoming a board member, call us at 223-7423. We'll be happy to talk to you."

I was very inspired by the teamwork of Put and Sue. East Montpelier is lucky to have such a dedicated couple working for its children's benefit. They truly are friends of education.

MORE ABOUT THE 21ST CENTURY PROJECT

Guy Viens has been hired as the Site Coordinator for East Montpelier's Community Connection program to be funded through a 21st Century Grant. Other staff will be hired soon to provide direct service. The program will be for both children and adults and will include a variety of course offerings that could range from homework support to drama, outdoor activities, cooking classes and much more. East Montpelier's Learning Center is still in the development phase but will include daily after school programs as well as some evening, weekend and summer offerings. As part of our goal to encourage adult and community involvement, surveys will be made available for your input.

Community members can get involved in many ways including teaching a course, taking one of the course offerings or working as a mentor/helper. Please take the time to return the surveys which will assist in developing a program that meets your needs. 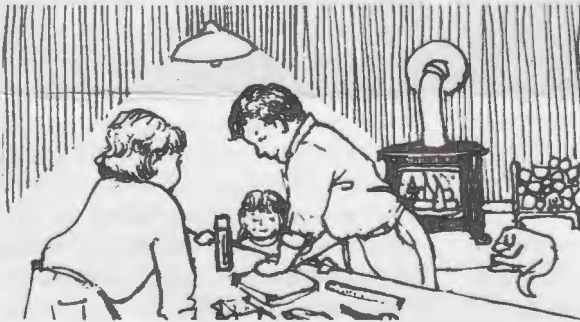

BIRDS R US PLUS

If you're ever looking for a really good place to buy a pet, I know just where you should go. "Birds R Us Plus", which is owned by Emma Grant and Paul Grant Sr. of East Montpelier. These people know their pets. Emma has her own pets, which include an African Grey bird and a Shar-Pei which is a wrinkly dog. Shar-Pei roughly translates from Chinese to mean

"sand paper coat". Her daughter also has two Chihuahuas, Fred and Lily.

Emma's store has everything from brightly colored birds to adorable kittens. Emma says it all started when her husband bought her a pet Parakeet about ten years ago. It quickly turned from a hobby into a wonderful, blooming full-time pet shop. The shop started in her house, then moved into the garage where it expanded as they remodeled and her business grew. But it's still a home, family run business.

As I entered the store, I saw many birds of all different colors and breeds. There were very loud chirping sounds coming from every direction of her store. I felt like I had just walked off a plane into the tropics of South America. When I asked Emma to name a few of the birds she had, she listed off every single kind of bird in there, Parakeets, Amazons, Lovebirds, Cockatiels, Finches, Macaws, Quaker Parrots and Cockatoos. It was amazing the different breeds she has there! And so many of them!

Most people want a bird they can hold, so Emma and her daughter, Heather, hand feed the baby birds starting at every two hours so they don't bite and make better pets. It takes them about three to four hours to feed all the birds. Emma's daughter feeds the birds in the store while Emma feeds the babies upstairs. They are usually done feeding and cleaning by ten o'clock, just in time to open the store. You may not realize it, but birds in other pet stores are not always hand fed. Emma does not buy her birds, she breeds her own. The top two floors of her shop are where the babies are born and kept until they are large enough to go into the baby tank in the shop to be sold. When I was there, she had a baby Cockatiel in her baby tank,

where she keeps the older baby birds. It was four weeks old and still being hand fed.

Emma has a cat room where she keeps her young kittens until she sells them. Emma also breeds her own cats. She keeps the males and females separated by buildings to control the amount of little ones. She will also take kittens, as long as they are at least eight weeks old. She brings them to the vet's for shots, then finds homes for them. Right now, Emma has a list of twelve people waiting for a kitten. If you are interested I'm very sure she would be happy to help you with one. So call her up and get on the list!

The shop is also full of other popular house pets such as Hamsters and Reptiles. Emma bought hamsters last year, and hasn't bought any more since they just keep reproducing. She occasionally has special offers on hamsters like "buy one get one free", or buy the cage and set up and get a free hamster. Her reptile corner has a bunch of Iguanas who were all basking in their heated cages. She also has fish tanks full of all different kinds of fish. The store includes supplies such as fish tanks, bird cages (some large enough for a person to stand up in), cat and dog toys and supplies, hamster and gerbil cages and toys, plus food for all different kinds of pets.

As I was taking the tour, I noticed two large birds sitting in their cages, which were as tall as I am! They were Amazons and were green with blue heads. These are called Blue Front Amazons. Blueberry had more blue than the other bird, who doesn't have a name yet. Blueberry was more talkative than the other bird, too. I was told they said things like "Hello" and "Hey guys", which they later proved right.

As you can tell, this is a fun place and is just what you're looking for in a pet store. "Birds R Us Plus" is located just off VT 14 on Fair Rd. in East Montpelier. The store is open Monday through Saturday, 10 am through 5 pm and is closed Sundays. So, drop by and look around, or you can call Emma yourself at 476-5904.
